AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NACOGDOCHES, TEXAS, PROVIDING FOR THE CALLING AND ORDERING OF A GENERAL ELECTION FOR THE CITY OF NACOGDOCHES TEXAS TO BE HELD ON MAY 2, 2026, BETWEEN THE HOURS OF 7:00 A.M. AND 7:00 P.M. FOR THE PURPOSE OF ELECTING A COUNCIL MEMBER FOR SOUTHEAST WARD AND COUNCIL MEMBER FOR SOUTHWEST WARD FOR TWO (2) YEAR TERMS, AND PROVIDING FOR THE NECESSARY NOTICES AND FIXING THE DATE.

WHEREAS, the City Council is desirous of holding an election as provided in said Charter of the City of Nacogdoches, Texas for the election of a Council member of Southeast Ward and a Council Member of Southwest Ward to be elected to serve two (2) year terms.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NACOGDOCHES, TEXAS:

Section 1. That an election be held in the City of Nacogdoches, Texas on May 2, 2026, for the purpose of electing the following named officers for the ensuing terms: Council Member of Southeast Ward and Council Member of Southwest Ward each for a term of two (2) years.

Section 2. That the City Council and Mayor be hereby authorized to call said election, at the time, place and in the manner as provided per the Texas Election Code and the Charter of the City of Nacogdoches, Texas.

Section 3. That applications shall be accepted in the office of the City Secretary, 202 E. Pilar Street, Room 320, beginning January 14, 2026 through February 13, 2026 from 8 a.m. to 5 p.m. for said positions.

Section 4. That said election and early voting shall be held and conducted at Nacogdoches County Courthouse Annex in the Nacogdoches County Elections Office located at 203 West Main Street, Nacogdoches, Texas 75961 and the entire city shall constitute one (1) election precinct.

Section 5. That said election be held in accordance with applicable provisions of the City of Nacogdoches Charter, Ordinance of the City of Nacogdoches, the Texas Election Code and the laws of the State of Texas.
